Higher Education Emergency Relief Fund Report Emergency Financial Aid Grants to Students

The Higher Education Emergency Relief Fund ("<u>HEERF</u>") established in accordance with Section 18004 of the Coronavirus Aid, Relief, and Economic Security ("<u>CARES</u>") Act provides funds to institutions of higher education to offer emergency financial aid grants from the HEERF to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance, such as food, housing, course materials, technology, healthcare, and child care).

Berkeley College of New Jersey, OPE ID: 00750200 ("<u>Berkeley-NJ</u>"), and Berkeley College of New York, OPE ID: 00739400 ("<u>Berkeley-NY</u>"), are providing this information to the public in accordance with the <u>Electronic Announcement of May 6, 2020</u> by the U.S. Department of Education ("<u>Department</u>"). - Berkeley-NJ and Berkeley-NY each (a) signed and returned to the Department a Recipient's Funding Certification and Agreement for Emergency Financial Aid Grants to Students under the CARES Act ("<u>USDOE Agreement</u>") and (b) has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
- 2. The total amount of funds that Berkeley-NJ will receive or has received from the Department pursuant to its USDOE Agreement is \$2,232,129. The total amount of funds that Berkeley-NY will receive or has received from the Department pursuant to its USDOE Agreement is \$2,298,437.
- 3. The total amount of emergency financial aid grants distributed by Berkeley-NJ to students under Section 18004(a)(1) of the CARES Act as of the date of this Report is \$2,417,978.90. The total amount of emergency financial aid grants distributed by Berkeley-NY to students under Section 18004(a)(1) of the CARES Act as of the date of this Report is \$2,342,068.06.
- 4. The estimated total number of students at Berkeley-NJ eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, and thus eligible to receive emergency financial aid grants under Section 18004(a)(1) of the CARES Act, as of June 30, 2020 is 1,953. The estimated total number of students at Berkeley-NY eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, and thus eligible to receive emergency financial aid grants under Section 484 in Title IV of the Higher Education Act of 1965, and thus eligible to receive emergency financial aid grants under Section 18004(a)(1) of the CARES Act, as of June 30, 2020 is 1,753. Note that the estimated number of eligible students indicated above was increased from prior reports by including

students enrolled in the Spring 2020 term based on guidance issued by the Department in the Supplemental Frequently Asked Questions under Section 18004 of the Coronavirus Aid, Relief, and Economic Security (CARES) Act published in June 2020.

- 5. The total number of Berkeley-NJ students who have received an emergency financial aid grant under Section 18004(a)(1) of the CARES Act as of the date of this Report is 1,432. The total number of Berkeley-NY students who have received an emergency financial aid grant under Section 18004(a)(1) of the CARES Act as of the date of this Report is 1,409.
- 6. The methods used by Berkeley-NJ and Berkeley-NY to determine which students receive emergency financial aid grants and how much they would receive under Section 18004(a)(1) of the CARES Act are as follows:

Based on guidance provided by the Department, students potentially eligible for an emergency financial aid grant were identified and sent a link to an electronic application. The application requires students to certify that they incurred expenses equal to or greater than the amount of emergency financial aid grant requested and that such expenses were related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance, such as food, housing, course materials, technology, healthcare, and child care). A maximum grant amount of \$1,245 per student was established based in part on the maximum amount of Personal Expenses of the Cost of Attendance for the Winter 2020 term. The application deadline was June 26, 2020. A second application phase commenced shortly thereafter to include students enrolled in the Spring 2020 term based on the June 30, 2020 guidance from the Department, updated on August 6, 2020. A maximum grant amount of \$800 per student was established for the second phase based on the amount of funds remaining. The application deadline for the second phase was August 14, 2020.
